
1           2.       By Operating Order dated July 6, 2005, the Superior Court authorized the payment  
2 of 80% of the monthly fees and 100% of the costs of the Conservatorship Estate.

3           3.       By Order Establishing Procedures for Interim Compensation and Reimbursement  
4 of Professionals dated February 17, 2006, this Court authorized the payment of 80% of the  
5 monthly fees and 100% of the costs of the Conservatorship Estate.

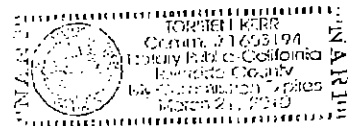
6           4.       Attached as **Exhibit "A"** to the *Second and Final Application of Dongell*  
7 *Lawrence Finney LLP for Payment of Reimbursement of Fees and Expenses* is a detailed
