

18 James C. Sell, the court appointed Conservator in the above-referenced matter,  
19 through counsel of record undersigned, hereby requests an accelerated hearing on his  
20 Motion for (1) Authorization to Enter into Deed in Lieu with The Reserve Spa, Inc., and  
21 (2) Authorization to Sell Real Property, which has been filed contemporaneously  
22 herewith. Pursuant to the Stipulation regarding Order Appointing Conservator;  
23 specifically, paragraphs 18 and 19, the Conservator is entitled to seek relief on an  
24 expedited basis wherein he is compromising claims or liquidating Conservatorship assets.  
25 The Motion which has been filed contemporaneously herewith requires the approval of a  
26 settlement with an existing borrower, which would then facilitate the Conservator's ability  
27 to liquidate an asset of the Conservatorship. The need for this matter on an expedited

1 basis results from the existing purchase contract which is scheduled to close Thursday,  
2 April 28, 2005. In order to insure timely closing, and compliance with the requirements  
3 for Title Insurance of First American Title Insurance Company, an Order must be  
4 obtained prior to that sale date.

5 Based upon the foregoing, the Conservator requests that this Court set a hearing  
6 prior to April 28, 2005 in order to hear the Receiver's Motion.


